#### TA PRESENTS

TA Shepard presented four (4) letters to the owners of the properties that were deeded to the Town that will need to be signed. She explained the letter states that the property has been deeded to the Town and the letters provide options relative to purchasing the properties back from the town. The letters also address the eviction process should the owners fail to repurchase.

TA Shepard presented a contract for Accufund support, the accounting software used by the Town. Support has been provided by Bluhm Shapiro in the past. They are no longer supporting Accufund. The new support company is Brisbane Consulting. TA Shepard indicated that it appears the level of support and the cost of the support are consistent to what has been provided in the past from the previous vendor.

The repayment has been satisfied and the property is being deeded back to the previous owners. The BOS signed the deed which will now be recorded.

TA Shepard stated the Town Clerk and Chairman Roy Sabourn have been served relative to an abatement action recently filed with the NH Superior Court. The town's attorney will be representing the town's interest on this filing.

TA Shepard shared a copy of a letter recently received by the Thornton Tax Collector relative to a BTLA ongoing abatement appeal. The Tax Collector will take no action on this letter, and it has been passed on the town's assessor.

TA Shepard shared with the BOS a recently watercolor painting by R. Fisher which was donated to the Town of Thornton by Gretchen S. of the Thornton Hollow Bridge which was washed out in the floods of 1938.
