Board of Selectmen Meeting Minutes November 10, 2020

12:30 p.m. Chairwoman Peabody opened the Thornton Board of Selectmen meeting work session with the Pledge of Allegiance. This meeting was held via Zoom with the link referenced on the posted agenda.

Discussion: J. Monti asked what the new tax rate will be. TA Shepard stated that the tax rate is \$20.11. The Board has used \$250,000 from the fund balance account to offset the tax rate.

- J. Monti is concerned that the overall tax rate has increased by 18%. Chairwoman Peabody explained the following reasons for the increase in the tax rate:
 - The Board had voted to increase the amount allowed for the Veteran's Exemption credit, the Elderly Exemption and the Totally and Permanently Disabled Exemption.
 - The State of NH has reduced the interest rate for penalties that the town collects for delinquent taxes.
 - The town lost anticipated revenues while the transfer station was closed due to COVID 19.

• The town budget also increased by \$250,000.

• The Board voted to approve an additional full time police officer position.

Chairwoman Peabody suggested that the Board review increasing their fee schedule in the future to help offset these expenses. Selectman Monti asked that this explanation be available in print format. The board agreed.
