Transfer Station Renovations

Capital Reserve Accounts

TA Shepard informed the Board that she contacted Michelle Clark from NHDRA regarding capital reserve account expenditures. M. Clark informed TA Shepard that the Board of Selectmen can spend more than was anticipated as long as funds are available in the appropriate capital reserve account. TA Shepard informed the BOS that Michelle is planning to visit the Town of Thornton and will meet with interested parties to discuss the Capital Reserve Account and CIP processes. She will schedule that with TA Shepard in the near future.

Vacation Time Request

TA Shepard received an inquiry from an employee to see if the Board would make an exception to the Personnel Policy regarding Vacation Time and allow him to receive paid vacation time before he earns it. This employee would be entitled to prorated vacation time of approximately 20 hours of vacation time (6.67 hours) earned on October 1, November 1 and December 1st. The Board was in agreement to allow this one-time exception with the condition that if this employee leaves his position with the Town of Thornton prior to December 1, 2019, he would need to pay this earned time back to the Town.
