    summary of the TCC activities and a two-page about the photo contest with photos from the
    TCC members.
  - 2020 TCC Quarterly Photo Contest
    - We have gotten four entries so far for 1Q 2021.
  - Vertex Cell Phone Tower No updates since the last meeting. Myrtle will contact Kathy Menici to get an update.
  - Proposed House Construction on Remington Road (with PRLAC) Katri conducted a site review (with PRLAC)
    - A house is proposed to be built very close to the steep bank of the Pemi River and there
      has already been scouring of the river channel. It was recommended that the house be
      constructed further from the river and trees not be removed (to stabilize the slope)
  - o Owl's Nest Jerry attended a recent Planning Board Meeting
    - There are applications to build 500 housing units; they have a permit to draw water from the Pemi to fill the <10 acre pond and also to keep the pond filled and for ongoing landscape irrigation; they have another 100 acres of land along the Pemi; they have a contract with Waste Management for trash and recycling; they plan to develop a trail along Mt. River East.
