At the meeting and public hearing held on June 20, 2019 and taking into consideration the application submitted as reflected in the minutes of said meetings and hearing, the Thornton Planning Board issues this permit as provided by the **Thornton Excavation Regulations and NH RSA 155-E**.

The approval is based upon the submitted application materials including the grading and restoration plan which have been reviewed by the Thornton Planning Board as well as the testimony by the applicant/agent. All abutters were notified. At the public hearing no abutter or members of the public spoke for or, in opposition, to the project. Abutter NH DOT was documented as an "approving" abutter.


The subject excavation must comply with the approved application and its conditions as well as the **Thornton Excavation Regulations and NH RSA 155-E**. Any expansion or change to the plan will require the applicant to meet with the Planning Board prior to making such planned changes to determine if an official amendment of this permit is needed.

Pursuant to **NH RSA 155-E:10** -The regulator or its duly authorized agent may suspend or revoke the permit of any person who has violated any provision of this permit, or this chapter, or made a material misstatement in the application upon which this permit was granted. Such suspension or revocation shall be subject to a motion for rehearing thereon and appeal in accordance with RSA 155-E:9.

This permit is not transferable without the prior, written approval of the Thornton Planning Board and is to be prominently posted at the excavation site or at the principal access pursuant to NH RSA 155-E:8.

In addition to the requirements of the **Thornton Excavation Regulations and NH RSA 155-E**, the following additional conditions affecting this permit are as follows:

- 1. Hours of operation:** Monday through Friday (No Sundays or Federal Holidays) 7:00 am to 5:00 pm and from 8:00 am to 12:00 Noon on Saturday.
- 2. Processing machinery:** No processing machinery allowed on this site.
- 3. Blasting:** Not allowed.
- 4. On-site storage:** Equipment may be refueled on site, but no storage of fuel is allowed on site. No storage of solid waste is allowed on site.
- 5. Water Quality:** No degradation of water quality shall be allowed to occur as a result of this excavation project.
- 6. Dust control measures:** May be required upon request by the Thornton Planning Board.
- 7. Backhauling, Importing and Storage of Material:** No Earth, concrete, asphalt or other material that did not originate from the site may be brought in, or stored upon, this site.
- 8. Crushing:** No crushing allowed on this site.
- 9. Bond/Surety:** Amount of Bond to be posted for site is Ten Thousand Dollars (**10,000.00**) to be renewed annually by the permittee. The applicant/permittee shall be responsible to timely file the annual bond renewal with the town.
