## Notice of Decision

At the Zoning Board meeting held on July 28, a Public Hearing was held to consider the request for an "EQUITABLE WAIVER OF DIMENSIONAL REQUIREMENTS from ARTICLE VI, SECTION A-2, LOCATION OF STRUCTURES." Any building or additions shall be set back at least 25 feet from any state, local or private highway/road right-of-way. A setback of 15 feet is required from any other boundary line, except that a 15-foot setback is required from the edge of any public or private non highway or non-road right-of-way.

The Zoning Board, after hearing from the Applicant, its agents, requested service providers, Zoning Compliance Officer Magoon, and members of the public in attendance and via Zoom/teleconference, and having previously determined that the application was complete, approved the Waiver by making the following motion:

MOTION: "To grant the Equitable Waiver of Dimensional Requirements for ARTICLE VI: Dimensional Requirements, Section A, 2: Location of Structure [Tax Map 207, Lot 8 (Formerly Map 2, Lot 6-4)]."
