At the Public Hearing held on December 21, 2023 and taking into consideration the application submitted, as reflected in the minutes of the meeting and said hearing, the Thornton Planning Board issues this **TEMPORARY** permit as provided by the **Thornton Excavation Regulations** and **NH RSA 155-E; until March 21, 2024.**

The approval is based upon the submitted application materials including the grading and restoration plan which have been reviewed by the Thornton Planning Board as well as the testimony by the applicant/agent. All abutters were notified. No abutters or members of the public spoke for or, in opposition, to the project.


The subject excavation must comply with the approved application and its conditions as well as the **Thornton Excavation Regulations** and **NH RSA 155-E.** **Any expansion or change to the plan will require the applicant to meet with the Planning Board prior to making such planned changes to determine if an official amendment of this permit is needed.**

Pursuant to **RSA 155-E:10** -The regulator or its duly authorized agent may suspend or revoke the permit of any person who has violated any provision of this permit, or this chapter, or made a material misstatement in the application upon which this permit was granted. Such suspension or revocation shall be subject to a motion for rehearing thereon and appeal in accordance with **RSA 155-E:9.**

This permit is not transferable without the prior, written approval of the Thornton Planning Board and is to be prominently posted at the excavation site or at the principal access pursuant to RSA 155-E:8.

In addition to the requirements of the Thornton Excavation Regulations and **RSA 155-E,** the following additional conditions affecting this permit are as follows:

- **Hours of operation:** 7:00 am-5:00 pm Monday through Friday and 8:00 am-12:00 noon on Saturday with no operation on Sunday or Federal Holidays.
- **Processing machinery:** Processing Machinery not approved for this site.
- **Blasting:** None permitted for this site.
- **On-site Storage -Solid Waste:** None permitted for this site.
- **Backhauling, Importing and Storage of Material:** None permitted for this site.
- **Crushing:** Not approved for this site
- **Bond/Surety:** Amount of Bond to be posted and maintained for this site is **\$10,000.00** and it is the responsibility of the applicant to renew the bond annually. Bond Renewal date is 10/23/2026.
