- Approval of minutes from December 14, 2020 motion to approve as written by Tony Torino, 2<sup>nd</sup> by Ralph Bradley, voted unanimous approval
- Position of current investments: WGSB, BNH rates unchanged no changes from December 14 meeting
- BNH CD matured 1/20/2021 funds moved to Bank of NH Pledged Collateral Fund as voted in December
- Balance at WGSB now, future potentially funds now at \$268,000, above the \$250,000 FDIC insurance limit on the town warrant is another \$32,000 for accounts at WGSB which would put us more than \$50,000 over FDIC discussion motion to move the Mill Brook Road account, approximately \$52,000, to Bank of NH Pledged Collateral Fund in order to get below and remain below the FDIC limit -motion to by Tony Torino, 2<sup>nd</sup> by Ralph Bradley, voted unanimous approval
- Investing options for existing funds other than change mentioned in prior article leave all other accounts invested as they currently are
- ◆ Year-end accounting Town Report, MS-9, MS-10 informational, no action required
- Fidelity Investments Cemetery Perpetual Care funds have now signed paperwork and will mail it tomorrow for getting online access and updated signature cards for Fidelity Investments – informational is the \$7,000 perpetual care funds in the bank drew only \$3.42 in interest in 2020 but the \$22,000 in perpetual care funds with Fidelity Investments drew \$416.64 in dividends plus a reinvested \$663 capital gain plus \$18.93 in interest – once our mailed paperwork is processed we might want to consider moving \$7,000 from the bank to Fidelity Investments
- Auditors March 22... materials for the auditors is ready to go, they are here week of March 22
- Investment Policy comparison of our policy with the town policy and with the notes in the auditors report lots of discussion, finally settled on 5 changes page 1, 5 lines up from bottom, change 'probably' to 'probable'; section V, line 5, 5<sup>th</sup> word, change', in' to ', or in'; section III, A. Prudence, 3<sup>rd</sup> line, Investments shall be made with judgment and care, as diversified as possible, under circumstances ... add in green text; section V, move entire text of the bullet point to a new section VI, COLLATERALIZATION; renumber former section VI as a new section VII motion by Tony Torino, 2<sup>nd</sup> by Ralph Bradley, voted unanimous approval draft to be e-mailed to trustees, if no changes in 5 days a final copy for signature will be mailed to Ralph Bradley who will sign and forward to Tony Torino who will sign and forward to Richard Baker.
